#5907 – Tidal Wave Gun Cleaner for Waterborne Paint
(Low VOC California Compliant) Aerosol 12oz.

DESCRIPTION

#5907 is a specifically formulated cleaner for spray guns which have been used to spray waterborne coatings, especially automotive basecoats.

WARNING

Because coatings & spray guns vary in nature, test in an inconspicuous area to determine compatibility before using on large areas.

APPLICATION

Consult label/MSDS and wear appropriate personal protective equipment before use. Always use product in a well-ventilated area away from sparks or flames.

Do not stick a pin or other sharp object into the hole in the top of the can, or expose cans to temperatures above 120°F (50°C).

Ensure that surface, air and product are between 50 – 85°F (10 – 30°C). Shake container briefly before use. If needed, firmly insert the spray tube into the end of the actuator.

For best results apply onto spray gun immediately after use, before paint has fully hardened. Hold can close to spray equipment and press actuator down to spray.

Allow #5907 to soak into the waterborne coating for several minutes, rubbing with a soft cloth. Aged coatings will need to be soaked with #5907 for prolonged periods, in excess of 10 minutes.

Do not allow Gun Cleaner to dry out: reapply as needed to keep surface wet with product. Rinse with cool, clean water.

Allow spray equipment to completely dry before reapplying Gun Cleaner, if necessary.

Place contaminated cloths in closed containers. Dispose of unneeded product, rinse water & contaminated cloths in accordance with local, regional, state, provincial and federal regulations.
